SUBJECT: PORT OPERATIONS 4th QUARTER ACTIVITY 2021

Moorage

In the 4th quarter, we experienced 27 terminations and assigned 27 spaces. Our turnover ratio decreased from 8.91% in 2020 to 4.08% in 2021.

The waitlist has 320 applications on file, compared to 225 in the 4th quarter of 2020.

Dry Storage

During the 4th quarter, Dry Storage had a 77.2% occupancy rate compared to 77.6% in the 4th quarter of 2020.

50 out of 51 trailer spaces are occupied: 90% occupancy.

Boat Move Activity:

- Total moves by the forklifts for this quarter = 1,211; that is a 19% decrease from the 4th quarter of 2020
- Launch activity increased 2% from the 4th quarter of 2020.
- Wash-down area use decreased 1% from the 4th quarter of 2020.
- The call ahead service increased 4% from the 4th quarter of 2020.

Equipment updates and repairs.

- Forklift repairs: None
- Launcher repairs: None
- The staff has maintained the launchers and forklifts this quarter per the maintenance schedule with assistance from the Maintenance Department. The team has maintained the wash pad area daily (rinsing it off), turned the valve, and cleaned the trench bucket weekly.

Public Launch

Round trips in the 4th quarter of 2021 show a 32% decrease from 2020

• 80 fewer round trips in 2021

One-way launches show a decrease of 1% from 2020

• 2 fewer round trips in 2021

Guest Moorage

The total number of guest moorage boats decreased by 9% (49 boats), and the total number of nights decreased by 11% (76 nights) during the 4th quarter of 2021.

There were 18 reservations during the 4th quarter of 2021 compared to 9 in the 4th quarter of 2020. The reservation program accounted for 23 nights in the 4th quarter of 2021 compared to 14 nights in the 4th quarter of 2020. Most of December, the general guest moorage area was occupied by the Edmonds Yacht Club for the Holiday on the Docks light event (11 total vessels for 308 nights).

Total Gallons pumped: Increased by 18% or 8,502 more gallons in 2021 compared to 2020.

- Gasoline increased by 6%
- Diesel increased by 26%








We experienced five-year highs for the number of boats, nights, and reservations.


Fuel Dock


Fuel Sales outperformed recent trends in all categories. Puget Sound Express ran two boats out of the Port for part of the summer, which increased diesel volume. The second summer of the COVID pandemic again led to a high level of boat usage within the local area, as represented by the uptick in unleaded gallons.










Water Moorage


