#### Moorage

In the 1st quarter, we experienced 13 terminations and assigned 24 spaces. Our turnover ratio remained at 1.96% in 2023, the same as 2022.

The waitlist has 352 total applications on file, compared to 355 in the 1st quarter of 2022.

# **Dry Storage**

During the 1st quarter, Dry Storage had an 80.7% occupancy rate compared to 83.5% in the 1st quarter of 2021.

53 trailers are stored in the Dry Storage area.

The launch activity was down 35% from the 1st quarter of 2022. Wash down area use was down 18% from the 1st quarter of 2022. The call ahead service usage was down 6% from the 1st quarter of 2022.

Total boat handling moves by the forklifts = 835

• 18% decrease from the 1st quarter of 2022

Equipment updates and repairs.

- Forklift repairs: Routine upkeep was completed. The Wiggins experienced electrical issues that have been remedied and the Taylor brakes and seat were replaced.
- Launcher repairs: Regular services completed.
- The staff has maintained the launchers and forklifts this quarter per the maintenance schedule with assistance from the Maintenance Department. The team has maintained the wash pad area daily (rinsing it off), turned the valve, and cleaned the trench bucket weekly.

The total number of guest boats decreased by 29% (77 boats), and the total number of nights decreased by 24% (99 nights) during the 1st quarter of 2023.

  - Water Samples: Samples taken in January 2022 passed all benchmarks for the General Boatyard Permit.
  - Fixed Facility Household Hazardous Waste Small Quantity Generator Report: This
    report is required to be filed annually for our Hazardous Waste facility and was
    submitted in February 2023.
- <u>Community Right-to-Know:</u> 2022 Tier Two reports were submitted to the Dept. of Ecology in February 2023.
- <u>Oil Transfer Reporting:</u> The Port of Edmonds is identified as a Class 4 Marina and Small Fueling Facility. As a result, we must report our total transfer volumes twice a year; January 15 and July 15. The Port Staff submitted this report during the 1st quarter.
- Oyster shell: The oyster shell in the vault was removed and fully replaced on March 23, 2023.

#### Fuel Dock

Total Gallons pumped: decreased by 15% or 4,016 fewer gallons compared to 2022.

- Gasoline decreased by 33%
- Diesel increased by 13%

Pay at the pump usage accounted for 78% of the total gallons pumped in the 1st quarter of 2023 compared to 72% in the 1st quarter of 2022.
